Part A Deductible Waiver Hospital Program for AARP Medicare Supplement Insurance Policy Holders

What is a Part A Deductible?

Medicare Part A provides benefits for inpatient stays in Medicare-approved hospitals. Medicare charges a deductible when you are admitted to the hospital. The deductible is charged to you once each benefit period.

What does Part A Deductible Waiver mean?

Each time an eligible AARP® Medicare Supplement Plan holder is hospitalized during a benefit period in a participating USA Managed Care Organization - Part A Deductible Waiver hospital, all or part of the Part A hospital deductible will be waived. What does this mean to me or other Medicare Supplement Policy holders?

One benefit of the deductible waiver program for AARP Medicare Supplement Plan holders is controlling rising health care costs. Policy holders are not required to use a Part A Deductible Waiver hospital, but this arrangement has the potential to stabilize health insurance premiums for Medicare Supplement Policy holders.

Can I still go to any hospital?

Yes, AARP Medicare Supplement Plan holders can still go to any hospital that they choose.
